ALLEGATION

The Council alleges that in relation to you, Ayesha Mahmood (01-38546), a registered optometrist:

- 1) On or around 14 June 2022, you conducted a sight test on Patient A and you:
 - a. Failed to identify that Patient A had a prosthetic left eye;
 - b. Failed to adequately examine Patient A's left eye in that you:
 - i. Failed to record the recent ocular history of Patient A left eye;
 - ii. Incorrectly recorded 'NPL' or no perception of light as the vision status in Patient A's left eye;
 - iii. Incorrectly recorded 'NMD' (no movement detected) for distance and near;
 - iv. Incorrectly recorded 'sluggish' and 'LE RAPD' (left eye relative afferent pupillary defect);
 - v. Incorrectly recorded anterior chamber (AC) as being 'quiet';
 - vi. Incorrectly recorded iris rubeosis;
 - vii. Incorrectly recorded no view of fundus opaque lens;
 - c. Failed to provide either a signed, written prescription for an optical appliance or a signed, written statement that Patient A does not need to wear or use an optical appliance as required by section 26 of the Opticians Act 1989;
- Your record of Patient A's eye assessment as set out at 1) b) ii, 1) b) iii, 1) b) iv), 1)
 b) v), 1) b) vi) and/or 1) b) vii above, was incorrect as Patient A's left eye was eviscerated;

And by virtue of the facts set out above, your fitness to undertake training is impaired by reason of your misconduct.
